- Our present term for Contractors and Builders are net 30 days.
- Service Charges of 1.5% per month will be added to accounts that are 31 days past invoice date.
- Should individual circumstances occur which prevent you from paying your account in a timely manner, please notify us so that we may work out an acceptable arrangement. PLEASE COMMUNICATE ANY POTENTIAL PROBLEMS TO US IN ADVANCE.
- Accounts which are 60 days past invoice date may be reported to Equifax and placed on CREDIT HOLD.
- Accounts which are 90 days past invoice date will be reported to Equifax as bad debt and turned over to collection attorneys.
- Accounts placed on CREDIT HOLD 2 times during a 6-month period will be closed.
- In the event that this account is placed in the hands of an attorney for collection for suit or otherwise, I agree to pay all costs of collection, including a reasonable attorney's fee, agreed to be 1/3 of total base debt owed at time the matter is turned over for collection.
- I hereby authorize to Quality Lighting Company, Inc., or their appropriate agent, to conduct a credit search and to investigate my credit. I agree to hold Quality Lighting Company, Inc. harmless for said search, which is done with my express permission by my signature below.
- I hereby personally and unconditionally guarantee the full payment and all indebtedness incurred under this credit application. This credit application shall remain in full force and effect until revoked in writing by me and all amounts owed up until that time I personally and unconditionally agree to pay. I personally agree to all of the terms of this application including the collection cost provision above.
